Eni Rovuma Basin B.V., Mozambique Branch, on behalf of Eni Mozambico S.p.A, invites interested companies to submit their Expression of Interest for the Provision of Mud Materials & Additivities Services to support operations in Area AS-A in Mozambique.

SCOPE OF WORK

The scope of work consists of Provision of Mud Materials & Additivities Services as detailed below in order to perform the drilling activities for the deepwater exploration well:

- Fluids (mud and brine) and chemicals:
- Service including the supply of equipment, materials, additives, solid control, filtration equipment and all relevant personnel;
- Fluids plants onshore with direct transfer line from LMP to PTS jetty Pemba Port;
- Waste Management Service (slope treatment unit);
- Tools for well clean up;
- Dedicated logistic base in Pemba surroundings, embarkation point for the equipment will be Pemba Port;
- Administrative & Operative Management based in Maputo;

The contract foresees a firm period needed to perform drilling and abandon activities on one (1) well.

The expected spud-in date is in Q1- 2022.

- Any other information that will establish ability of fulfilling this scope of work.

- Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Company;
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
