Such Drillship is required to have the following characteristics:

- Full dual activity drilling rig
- Dynamic Positioning Unit DP3
- Dynamic Positioning Unit required to be fit & equipped for Zero Discharge
- Rated Water Depth 3,000 m
- Drilling Depth min 5,500 m
- Drillship 6th generation upward
- Capability to work in strong current environment with suitable drilling riser system
- Proven experience operating in cyclone areas
- Five-year certification that covers interval Q3 2025 up to Q1 2027
- Equipped with cementing unit and fully commissioned
- Equipped with flaring system for well testing.

The contract foresees:

- A firm period needed to perform drilling, completion and clean up of four (4) wells in Mozambique Area 4. The expected spud-in date of the well is in Q3-2025;
- Plus, an optional period needed to perform drilling, completion and cleanup of two (2) wells in Mozambique Area 4 in direct continuation.

Rig contractor MUST open a local branch in country with administrative & operative management based in Maputo and dedicated logistic base in Pemba within one month before spud-in date.
