

REQUEST FOR EXPRESSION OF INTEREST

PROVISION OF LOGISTIC BASE & INTEGRATED LOGISTICS SERVICES

Eni Rovuma basin B.V., Mozambique Branch – Upstream Delegated Operator, acting for and on behalf of Mozambique Rovuma Venture, Area 4 Operator, invites interested companies to submit *Expression of Interest* for the provision of Logistic Base and Integrated Logistics Services, mainly in Pemba, in order to support the logistic activities for Area 4 upstream operations.

SCOPE OF WORK

The Scope of Work includes the provision in Pemba Area of a Logistic Shore Base on a permanent rental basis with direct access to Marine Quay (adjacent to the shore base) and logistics services including but not limited to the provision of lifting equipment (lifting appliances), land transportation (trucks with trailers), offshore cargo carrying units (CCUS), slings & lifting accessories, vessel tank cleaning services, provision of manpower, inspection & recertification services, Port authority services (cargo transfer), drilling & fresh water and consumables to continuously support COMPANY operational activities mainly in Pemba, Cabo Delgado province, Mozambique.

Moreover, the SERVICES shall be inclusive of all maintenance in the logistic shore base facilities, open areas and marine quay to continuously support COMPANY activities.

The Logistic Shore Base and the Marine Quay shall be connected to road network allowing safe transit and movement of heavy trucks and material handling equipment (e.g. mobile cranes, forklifts). The access roads to the logistic base and marine quay shall be object of technical evaluation and shall be constructed and/or maintained by CONTRACTOR in a condition suitable for easy entry and exit under all weather conditions during the whole contract duration.

Logistic Shore Base Estimated Area Requirements

CONTRACTOR shall provide an overall area initially estimated to be in the range of 35.000m2 (excluding access roads) with possibility for extensions (preferably adjacent), and a total of at least additional circa 25.000 m2 complete with adequate drainage and totally fenced, including covered warehouse with cold room and PPE store, open storage area with pipe racks, shelter/ chemical hazardous stock, waste storage area, shore base offices and parking area.

The open area surface should be made of selected material with proper sieve gradation and well compacted, asphalted or cemented. In any case the minimum soil bearing capacity shall be no less than 10 ton/m2.

Marine Quay Facilities Requirements

Marine Quay Facilities include Fixed Quay/Floating Quay provided that these will have enough length, width, water depth and bearing capacity to support COMPANY operations. Long term solution will envisage the availability of at least 300m fixed quay.

In case a floating quay/barge is provided it shall be granted that the quay and all the transit facilities (connecting bridge) are capable of handling the transit of heavy (min 100 tons) and out of gauge materials.

All permitting, licensing and authorizations required to execute the above Scope of Work and any road interventions (rehabilitation and maintenance) shall be arranged by the Contractor with the competent authorities and in full compliance with the legal requirements.

The SERVICES are envisaged to be made available indicatively from the beginning of the 2^{nd} Quarter 2023 for a tentative firm period of 120 months plus two optional extensions of 60 months each.

DOCUMENTATION REQUIRED

Companies interested in this invitation may submit their *Expression of Interest* by providing the following mandatory information and documentation:

I. Technical documents

- a) Alvará which attests vendor's registration in Mozambique for the provision of Logistics Services herein requested;
- b) Proven experience in the provision of Logistic Shore Base, Marine Quay and Logistics Services including but not limited to lifting equipment (mobile cranes, telescopic handlers and forklifts), land transport (trucks with trailers), offshore cargo carrying units (CCU's), slings & lifting accessories, third-party inspection & recertification services, vessel tank cleaning services, provision of drilling water/fresh water, provision of logistics manpower or similar services in Oil & Gas industry;
- c) Description of the proposed logistic shore base facilities;
- d) Availability in Pemba Area of Marine Quay facilities (fixed/floating) connected/adjacent to the proposed Logistic Base with the following minimum characteristics: 110 m length, 30 m width, 10 m depth and 10 t/m2 bearing capacity – include detailed technical description of the quay facilities;
- e) Direito do Uso e Aproveitamento de Terra (DUAT) for the proposed Logistic Base Area; in case the DUAT is not under vendor's name, to provide the agreement with the ultimate owner of the DUAT;
- f) License/authorization from the relevant Authority or other entities appointed by the

Government of Mozambique allowing/licensing the Candidate to operate the proposed Marine Quay facilities and Logistic shore base to support Oll & Gas operations. Main terms of the License/Authorization and/or Concessions to be provided;

- g) Having Quality Management System certifications proving compliance with international Quality Standards (e.g. ISO 9001:2008 / 2015);
- Health, Safety and Environment Management System documents proving compliance with international standards (ISO 45001 and ISO 14001);
- i) HSE Policies;

Company's HSE performance including events and incidents in the last three years. Total Recordable Incidents Rate (TRIR) shall be provided.

II. Administrative documents

- a) Scanned certified copy of the Trade Register, Legal Entity name and contact person for receiving qualification package and other relevant information from the Eni Rovuma Basin B.V₂
- b) Last three years Financial Statements and Annual Report including Balance Sheet, Profit and Loss and Cash Flow Statement. These documents must be provided for the Company Group (if applicable), and also for the Company's Mozambican registered entity that will enter into the subject contract;
- c) Company's registration in Mozambique. In case your Company is not already registered in Mozambique, please specify if you would be willing to promptly register in Mozambique and specify the respective timeline;
- d) Company and Group Structure with the list of major Shareholders and ultimate beneficiaries (if not listed in the stock exchange);
- e) In case you wish to participate in the Expression of Interest as a consortium or as a joint venture, information about each member of consortium or joint venture and role of each participant in the potential project. Such intention to form either a consortium or a JV, must be supported by an Agreement or "Memorandum of Understanding" duly signed by each entity in the group.
