EXPRESSION OF INTEREST FOR PROVISION OF COIL TUBING & PUMPING SERVICES

Eni Rovuma Basin B.V.- Mozambique Branch, invites interested companies to submit their Expression of Interest for the Provision of Coil Tubing & Pumping Services to support Eni Rovuma Basin B.V. gas field development activity in Mozambique.

SCOPE OF WORK

The scope of work consists of Provision of Coil tubing and pumping services as detailed below in order to perform the well operations activities for the offshore deepwater project:

- For the development wells the coiled tubing and pumping services are required to assist the clean-up and well testing phases and as a contingency through tubing well intervention plan working up to a total depth of more than 5,000 m. In case of well problems, the following operations are expected for coiled tubing:
 - o Nitrogen lift operation
 - o FIV (formation isolation valve) shifting and or milling
 - o Acid job
 - o Clean out operations
 - o Unplanned fishing
- · Dedicated logistic base in Pemba area is required;
- Provide on rental basis Compensated Coil tubing Lifting frame;
- · Administrative & Operative Management based in Maputo/Pemba.

The development project foresees:

- the drilling, completion and clean-up of four (4) wells in Mozambique Area
 4. The expected spud-in date of the well is in Q3-2025 with possible starting of the completion and well testing operation in Q4-2025.
- Plus the drilling, completion and clean-up of two (2) optional wells in Mozambique Area 4.

Contractor MUST open a local branch in country with administrative & operative management based in Maputo and dedicated logistic base in Pemba in due time for the support of the drilling activities.
