The Hidroeléctrica de Cahora Bassa, S.A. («HCB») intends to launch the above call for tenders, the purpose is to contract specialised services to identify, map and quantify greenhouse gases resulting from its activity or process. In this context, this Call for Expression of Interest is made to all companies that cumulatively fulfil the following minimum eligibility requirements:

Company's Requirements

- a) Updated Commercial Registration Certificate (valid for at least 3 months), issued by the competent Legal Entities Registry Office, identifying the persons authorized to bind the company;
- b) Official Gazette (national commercial companies only) with the publication of the articles of association;
- c) Powers of attorney conferring powers to bind the company, if applicable;
- d) Licence to carry on business;
- e) Certificate of Discharge, containing the NUIT (Unique Tax Identification Number);
- f) Company's letter giving details of the bank account to which HCB is to make the payment, issued on the organisation's letterhead and signed by the Finance Director or General Manager (Bank details should include Bank Name, Branch/Office, Account No., NIB or IBAN and Swift code);
- g) Letter issued by the bank confirming the bank details given in the previous item;
- h) To have carried out at least 05 works of the same or similar scope, presenting the aforesaid reference letters.

Requirements of the Technical Team

- a) The proposed team must have certification compatible with the scope of the work to be carried out;
- b) Possess a certificate of specific training related to the quantification of Greenhouse Gases;
- c) Fluency in Portuguese is a differentiating requirement,
- d) References of similar work (GHG quantification), at least 05 (five) years.
- e) Having carried out quantification/training of GHG emissions in Hydroelectric Power Plants is a differentiating factor.

The required qualifications must be proven by means of a detailed CV, reference letters, declarations and attestations issued by suitable public or private, national or foreign organisations.
