  the African Development Bank hereinafter called the Bank toward the cost of the Climate Insurance,
  Finance and Resilience Project, and intends to apply part of the proceeds toward payments under
  the contract for Supply, of (17) seventeen Vehicles for the three Provinces covered by the CLINFIREP
  namely Maputo, Gaza and Inhambane. For this contract, the Borrower shall process the payments
