1. BACKGROUND

Sasol Petroleum Mozambique Limitada ("Sasol") invites interested companies to provide responses to this pre-qualification EOI process. The Participants must be a registered Mozambican legal entity.

The Project seeks to construct and install new gas gathering systems, incorporating manifolds, flow and trunk lines between existing and new wells in the Temane, Inhassoro and Pande areas in Mozambique, through to the Sasol Central Processing Facility (CPP) and related Plant.

This advert seeks the services of an established and experienced company that can provide qualified services associated with the construction and installation of the gas gathering systems and related interfaces to facilitate the overall PSA Project objectives. Additional responsibilities shall include construction safety management and quality control as required.

For the purposes of this EOI pre-qualification notice, the following requirements must be met and the respondent should demonstrate compliance with concise applicable documentary proof. In support of the construction of the PSA Project, amongst others, the provision of Mechanicals, Piping, Pipinie and Civil Construction Servision of Mechanicals.

2.OBJECTIVE OF THIS REQUEST FOR EXPRESSION OF INTEREST (EOI)

The Project seeks the services of a mechanical, piping, pipeline and civils Contractor with proven remote site upstream gas field and pipeline construction experience. The Contractor will be required to:

- Prepare and gain acceptance of detailed Method Statements for all Works and activities
- · Fabricate pipe spools, including inspection and testing;
- · Assemble and fit above-ground piping, valves, structures and associated facilities;
- Installation of electrical earthing and lightning protection:
- . Fabrication and installation of structural steel work:
- . Civil, road and pipe-jacking works, as required:
- · Supporting construction and works to enable functional gas & oil wells;
- . Trench and Civil preparation of trench works to accept line pipe
- Weld and field install approximately 75 kilometres of coated underground gas and water pipeline in multiple dimensions between 6-inch and 16-inch and differing wall thicknesses to specified design (pipe materials will be free issued);
- X-ray inspection and other non-destructive testing of welds;
- · Apply field joint coating at welds;
- Hydro-test, cleaning plus drying and certify the constructed pipe work and flow lines;
- Installation of Cathodic Protection
- · Dimensional inspection (pigging) of the lines; and
- · Assistance with commissioning of the newly constructed piping systems and wells.

The Contractor will need to mobilise qualified personner and equipment at remote locations, for the duration of the works. The mechanical, pipeline and cathodic protection design will be provided by the Employer. The Contractor will be responsible former the establishment and management of own assets, sub-contractors and service providers, as required.

3. ESSENTIAL DOCUMENTATION AND INFORMATION THAT IS REQUIRED TO BE SUBMITTED:

Sasol hereby invites eligible Contractors to indicate their interest in providing the work described above. Interested eligible Contractors should supply information proving that they have the required qualification and relevant experience to perform such work in Mozambique. Respondents are advised to keep their response brief (i.e. a maximum of 10 pages will be accepted), to the point and only provide the essential information. All documentation shall be provided in the English Language. Where essential documentation is in Portuguese, provide a short English narrative explaining the Portuguese content.

Essential documentation and information required include:

- Ownership structure (percentage shareholding held by shareholders as well as a description of the identity of shareholders, i.e. >50% national equity or <=50% national equity).
- 2. Company registration certificate, applicable commercial license(s), IVA/VAT sales tax number.
- Relevant financial information of the company (last 3 years turnover, net profit after tax and total equity reserves).
- 4. Technical capability:
- Provide track record of applicable work done;
- Detailed CVs of all key personnel indicating relevant qualifications including degrees, diplomas, etc., accreditation and certification, and relevance to the project work undertaken;
- List of projects done in the last two years with similar scope and location; and
- Capable of working to Sasol and applicable International specifications and quality standards.
- 5. Proven safety track record and accredited safety system must be in place.
- Contractor must be well established and have an accredited quality management system. Certification to ISO 9001 is required. It is also mandatory to have a welding quality system certified and managed to ISO 3834 part 2.
- 7. Contractor must prove knowledge of contracting and contract execution to NEC3.
