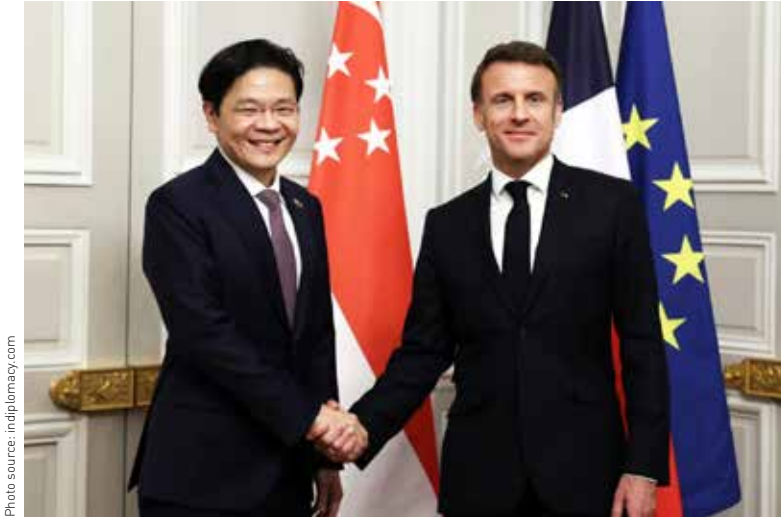

JYOS 2024: A Collective Journey Towards a Sustainable Future



At the French Chamber of Commerce in Singapore, sustainability has been a cornerstone of our mission since 2020. In 2024, the **Joint Year of Sustainability between France and Singapore (JYOS)**, was officially announced in Paris by **Deputy Prime Minister Lawrence Wong** and **President Emmanuel Macron**. Running through mid-2025, JYOS marks a significant step forward in fostering Franco-Singaporean collaboration on environmental challenges.

A major highlight of JYOS was the **France-Singapore Circular Economy Forum**, organised by the French Chamber of Commerce on **20 June 2024** during the CleanEnviro Summit, with the support of the French Embassy and the French Foreign Trade Advisors (CCE). This event gathered experts from corporates, research institutions, and industries to explore new strategies and innovations driving circularity and sustainability in business models. Discussions emphasized the importance of **designing for durability and reusability** and showcased best practices for transitioning towards a more circular economy.

Building on this momentum, we also organised a series of practical workshops and activities under the initiative “**Circularity – 3 Days to Rethink, Reuse, Recycle**,” including the **Circular Economy Innovation Masterclass**, the “**No More Waste**” Circular Economy Collage workshop, and site visits to pioneering companies. These programs provided hands-on opportunities for members to rethink traditional models and adopt more sustainable business practices.

As part of the **Singapore International Energy Week (SIEW 2024)** and with the support of the French Embassy, the Chamber co-hosted an exclusive roundtable on **Accelerating Decarbonisation in Singapore and the Region**, gathering over 170 participants, including top industry leaders and ASEAN representatives. This event was an outstanding platform for exchanging insights and fostering regional collaboration towards carbon neutrality.

During the **Singapore Maritime Week in March 2025**, we held the **French-Singaporean Maritime Roundtable Discussion and Networking Event** at the Fullerton Hotel. Organised in collaboration with the French Embassy and the French Directorate General for Maritime Affairs (DGAMPA), the event featured two thematic discussions on key maritime challenges, fostering valuable dialogue between French and Singaporean stakeholders in the maritime sector.

Through our **Sustainable Business Committee** and **CSR Club**, we provided platforms for meaningful collaboration, peer learning, and collective progress.

To amplify the impact of these initiatives, we published **three special editions of our FOCUS Magazine in 2024**, exploring the major pillars of tomorrow's economy: **Smart Mobility, Circular Economy, and Implementing New Energies**. These editions celebrated innovative solutions and recognized the leadership of companies committed to building a more sustainable future.

We firmly believe that **the transition to a more responsible economy requires collective ambition, innovation, and action**. We are proud to walk this path alongside our members, partners, and the wider community and we remain deeply committed to supporting sustainable growth in Singapore and beyond.

SINGAPORE MARITIME WEEK 2025: 24 – 28 MAR 2025

Singapore hosted two major maritime events — Singapore Maritime Week (24-28 March) and the 10th edition of Sea Asia (25-27 March) — gathering over 40,000 professionals from nearly 100 countries. Highlights included a visit to the Port of Singapore, networking sessions hosted by TotalEnergies, and the “French-Singaporean Maritime Roundtable Discussion and Networking Event,” all of which fostered meaningful exchanges and the formation of strategic partnerships.

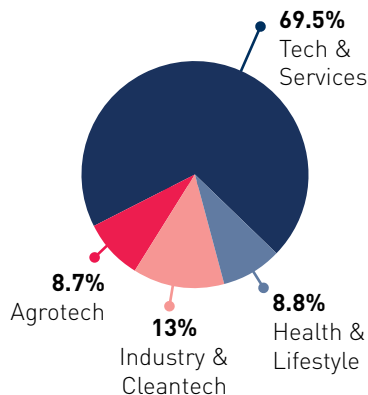

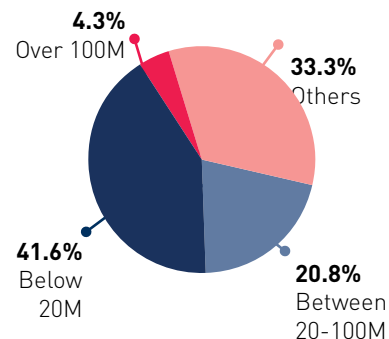
2024 SET-UPS BY STRUCTURE

2024 SET-UPS BY WW TURNOVER IN SGD*

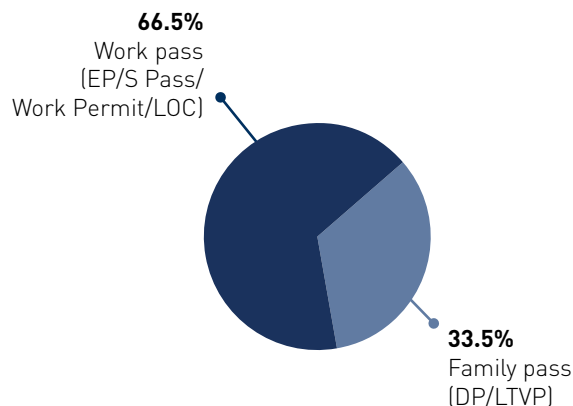

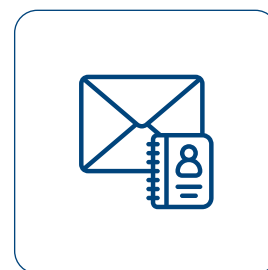
