MFUND


The Migrant Fund, a low-cost not-for-profit health protection scheme for migrants in Thailand. M-FUND members make a low monthly contribution starting at only 130 Thai baht per person, which covers access to broad-quality healthcare services in a network of partner hospitals and clinics along the Thai border provinces.

CFREE

Eliminate Hep C is a study on a community-based model of care for the diagnosis and treatment of hepatitis C (HCV) and other infectious diseases for people who use and inject drugs. There are 12 C-FREE community sites across Thailand. C-FREE has provided care for more than 6,000 participants and also had positive policy impact in the country, as it led to removal of drug use as an exclusion criteria for treatment of hepatitis C under the national treatment program, in Nov 2022.



Founded in 2015, **Dreamlopments** is a Thai non-profit delivering innovative, high-impact solutions to improve access to care for marginalized communities.

Action Location: As of October 2025, Dreamlopments operates M-FUND with teams in 8 provinces and recruited migrants online from 15 more, including Bangkok, Samut Sakorn, and Phuket. C-FREE runs 12 sites across 10 provinces, including Bangkok, Chiang Mai, Khon Kaen, and Songkla.

Size	We have 115 full-time employees: - For M-FUND field teams: 78 staff (Project Managers, Project Officers, Community Workers). We also involve 70 part-time Community Relays paid by incentives for their project contributions For C-FREE Study field teams: 26 staff (Nurses, Assistants, Physicians) - For Head Office: 11 management staff.
Beneficiary Nationality	The beneficiaries of M-FUND project are Burmese, Cambodian, Laotian. Some stateless members are also covered. For C-FREE, beneficiaries are mostly Thai nationals (95%). 5% are Burmese residing in Thailand.
Action Impact	As of October 2025, over 100,000 people have already voluntarily enrolled in M-FUND project, and 150,000 Outpatient Consultations and 20,000 Inpatient Admissions have been covered for M-FUND members, for a broad range of health conditions. M-FUND has already reached 67% financial autonomy. C-FREE has already provided care for almost 6,000 participants, and delivered curative HCV treatment for 2,000 of them. C-FREE has also has positive policy impact in the country, as it led to removal of drug use as an exclusion criteria for treatment of hepatitis C under the national treatment program, in Nov 2022.
Use of Donation Funds	- M-FUND project (50%): supporting the operation efforts of extension of M-FUND coverage for refugees living in camps along the Thai-Myanmar border C-FREE project (50%): supporting the activities that will assess the effectiveness and cost-effectiveness of a shorter treatment of HCV for people who need it most (people who use drugs).
Long-term Vision & Alignment	a) to make M-FUND financially self-sustained, whereby member contributions cover more than 80% of all project costs (currently, 67%) b) to extend M-FUND to other countries around the world where similar needs exist to provide health protection to migrants and refugees. For C-FREE, our long-term vision is to inform the policy decision of the Thai Ministry of Public Health to fund services of community-based care for diagnosis and treatment of HCV for people who use and inject drugs.
