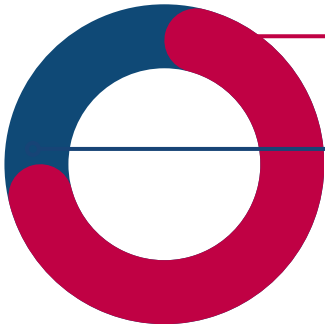

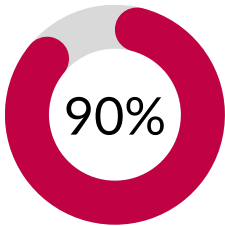

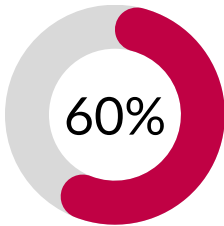

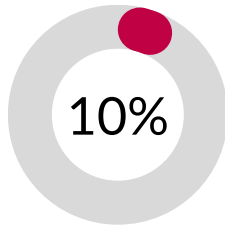
GEOGRAPHIC PRESENCE

The regions where French companies are most present with industrial, agricultural, and logistical activities are:

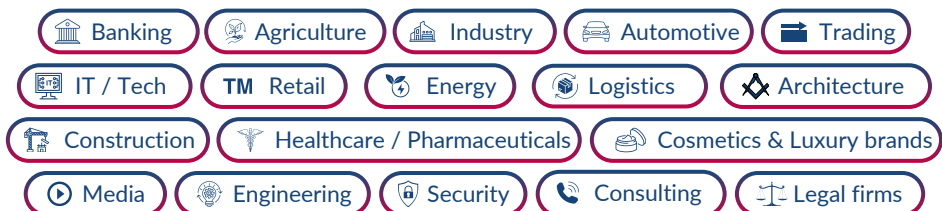
